



THE PRICE OF THE ASSESSMENT FOR PERSONS WITH INTERNATIONAL PROTECTION

Candidates with international protection are entitled to take both exams (i.e., the assessment) free of charge twice, i.e., the costs of the assessment are covered by the Government Office for the Support and Integration of Migrants. The costs of any further exam retakes will be covered by candidates (Article 30 of the Decree on the methods and conditions for ensuring the rights of persons with international protection, The Official Gazette of the Republic of Slovenia, No 72/2017).

THE PRICE OF THE ASSESSMENT

Assessment: English and Mathematics	€178
Price of one exam	€89

For the application to be valid, candidates must pay for the exam and must, when applying, submit proof of payment.

METHOD OF PAYMENT

Candidates pay the sum via a universal payment order (Slovene abbreviation: UPN) to the address Državni izpitni center, Kajuhova ulica 32U, 1000 Ljubljana, to the checking account number 01100-6030632914, reference SI00 34006, and add their personal identification number (EMŠO). The UPN must contain the name and family name of the candidate applying for the assessment or the exam.

NB: Should you have problems filling in the UPN form, split the candidate's personal identification number into two parts by inserting a hyphen after the year of birth.

Example: Instead of SI00 34006-0101999505011, write SI00 34006-0101999-505011.

Candidates wishing to receive a receipt proving they paid for the exams must send a request including the following information via e-mail (to the e-mail address info@ric.si) or regular mail (to the address of the National Examinations Centre):

- name and family name,
- e-mail address, if they wish to receive the receipt via e-mail, and
- date of payment.

WITHDRAWAL OF THE APPLICATION AND REFUNDS

Candidates can withdraw the application for either the assessment or the exam they failed no later than three days before the day of the exam, in writing (Article 25 of the Decree on the methods and conditions for ensuring the rights of persons with international protection, The Official Gazette of the Republic of Slovenia, No 72/2017).

In this case candidates send to the National Examinations Centre a written statement on withdrawing the application for either the assessment or the exam they failed as well as a written request stating the candidate's name and family name, their address and their personal account number for the refund, from which €2.10 for administrative costs are deducted. It is necessary to submit a photocopy of proof of payment.

If candidates withdraw the application too late or fail to attend either the assessment or just one exam, this means that they failed one or both exams.
