ENTRY OF PROVIDERS INTO REGISTER OF PROVIDERS OF ASSESSMENT AND CERTIFICATION OF NATIONAL VOCATIONAL QUALIFICATIONS

REQUIRED CRITERIA FOR PROCEDURES OF ASSESSMENT AND CERTIFICATION OF NATIONAL VOCATIONAL QUALIFICATIONS

DOCUMENTS FOR ENTRY INTO REGISTER:

1) PROPOSAL FOR ENTRY INTO REGISTER

2) ENCLOSURES FOR ENTRY INTO REGISTER:

- data on material conditions. (www.ric.si/kvaifikacije/izvajalci);
- a statement on meeting material conditions determined by the Catalogue of Standards of Professional Knowledge and Skills (www.ric.si/kvalifikacije/izvajalci);
- a statement that material conditions, after entry into the register, shall not deteriorate or become inadequate (www.ric.si/kvaifikacije/izvajalci);
- a certificate on the qualification of portfolio adviser;
- a statement that the provider shall provide portfolio guidance to candidates wishing to acquire vocational qualifications (www.ric.si/kvalifikacije/izvajalci);
- a general act of the organisation from which it is evident which organisation unit will be responsible for performing the activity, and paragraphs, if it contains several organisation units;
- documents of proof of meeting material conditions from which it follows that material conditions for the qualification in question as determined by the Catalogue of Standards of Professional Knowledge and Skills are met (www.ric.si/kvalifikacije/izvajalci);
- an estimate of the number of certificates issued per year:
- a statement that the records of issued certificates shall be kept in accordance with regulations and directives of the National Reference Point (www.ric.si/kvaifikacije/izvajalci);
- the name of the person responsible for the performance of procedures of assessment and certification of national vocational qualifications;
- an excerpt from the register of companies, not older than 30 days proving that the organisation wishing to become a provider is registered for the activity in question or other educational activity, is acquired by the National Examinations Centre.

PROVIDER sends the proposal for entry into register together with all required enclosures to the National Examinations Centre. NATIONAL EXAMINATIONS CENTRE acquires an excerpt from the register of companies and verifies the meeting of criteria for entry into register. **PROVIDER** meets the required criteria for entry into register. NATIONAL EXAMINATIONS CENTRE issues a decision of entry into register if the provider meets all criteria determined by the Rules on keeping the register of providers of procedure for assessment and awarding of national professional qualifications.


NATIONAL EXAMINATIONS CENTRE enters provider into the register.

PROVIDER

does not meet the required criteria for entry into register.

NATIONAL EXAMINATIONS CENTRE

issues a decision by which it rejects entry into register, if the provider does not meet criteria determined by the Rules on keeping the register of providers of procedure for assessment and awarding of national professional qualifications.



CRITERIA FOR ENTRY INTO REGISTER:

- providers of procedure for assessment and certification of national vocational qualifications have to meet the required criteria;
- providers need their own premises and equipment as required by the professional standard and the Catalogue of Standards of Professional Knowledge and Skills (a basic criterion).



ENTRY INTO REGISTER

- The register of providers for assessment and certification
 of national vocational qualifications can only include
 chambers, schools, adult-education organisations and
 business education centres as well as institutions,
 societies and other legal entities complying with material
 and staff conditions determined by the Catalogue of
 Standards of Professional Knowledge and Skills, as well
 as other acts, if thus determined by special regulations.
- For areas where conditions in organisations from the previous paragraph are not met and if the National Examinations Centre within the period of 30 days after the publication of the Catalogue of Standards of Professional Knowledge and Skills in the Official Gazette of the Republic of Slovenia does not receive an application for entry into the register, the National Examinations Centre selects a provider of procedures for the assessment and certification of NVQs based on public invitation for tenders.

The system of assessment and certification of national vocational qualifications in Slovenia is regulated by the **National Professional Qualifications Act** (Official Gazette of the Republic of Slovenia, Nos 81/2000, 55/2003, 118/2006, 1/2007).
